## Level - 2

The main focus of this course is on the learners' preparation for undertaking the Certified Management Consultant (CMC®) certification with the IMC-USA. The Certified Management Consultant (CMC®) mark is awarded by the IMC USA to consultants who have achieved a level of performance that includes professional standards in technical competency and ethics, and global standards in consulting competencies, professional behavior, client and project management, and personal conduct. There is no requirement for membership in any professional association or to attend any specific course to apply for the CMC®, but this course will give you the preparation you need to enter the profession. Learners will critically examine the nature and purposes of management consulting within the Global marketplace, and they will develop an understanding of
